# **General Revenue**

General Revenue collections for April totaled \$388,531,834, **falling below** the monthly estimate of \$580,807,000 by \$192,275,166. Bringing the total year to date General Revenue collections to \$3,691,840,165.

As of the end of April the state has collected 78.66% of its total estimated yearly revenue of \$4,693,640,000. At this time, the state should have collected 82.72% of its yearly revenue.

#### **Personal Income Tax**

Personal income tax (PIT) collections for the month were \$206,774,563. This figure is \$132,525,437 **below** the April estimate of \$339,300,000. The total year to date personal income tax collections for fiscal year 2020 are \$1,641,668,963.

As of the end of April the state has collected 76% of its total estimated PIT yearly collections of \$2,154,880,000. At this time the state should have collected 84% of its PIT yearly collections. This current trend puts the state **not on track** for meeting the PIT yearly collections estimate.

### **Consumer Sales and Service Tax**

Collections of the Consumer Sales and Service Tax (CS&S) for the month of April were \$92,700,238 and were \$8,799,762 **below** the monthly estimate of \$101,500,000. Total Consumer Sales and Service Tax collections for fiscal year 2020 are \$1,116,794,274.

As of the month of April the state has collected 80.33% of its yearly estimated collections. At this time the state should have collected 80.68% of its yearly estimate. This current trend puts the state **not on** track for meeting the yearly CS&S tax collection estimate.

#### **Severance Tax**

Severance tax collections for April were \$10,307,315. This figure is \$15,432,685 **below** the monthly estimate of \$25,740,000. Total severance tax collections for fiscal year 2020 are \$232,434,939.

As of the end of April the state has collected 65% of its total yearly collections of \$376,800,000. At this time the state should have collected 81% of its yearly severance tax collections. This current trend puts the state **not on track** for meeting the yearly severance tax collection estimate.
